Super Neighborhood 17 – Eldridge/West Oaks Minutes from the meeting of February 08, 2023, 7:00 PM

- I. Call to Order President, Jeff Baker called the meeting to order. Quorum was not met.
- II. Public Safety Officer Tim Whitaker provided a summary of crimes in SN-17 for the month of January as compared to December. Two murders took place in SN-17 in January. A man shot his mother multiple times and killed her live-in boyfriend at a home in the 2300 block of Binley near Wickersham Lane. The second murder was the result of a road rage incident. (See crime stats below)

III. Guest Speaker, Sallie Alcorn, COH Council Member At Large – Position 5

A. Houston Housing Authority (HHA) developments and Public Facilities Corporation (PFCs): In 2015, the TX legislature adopted a PFC structure under Section 303.042(f) of the Texas Local Government Code, which allows developers that build mixed-income housing to claim full property tax exemption in exchange for renting half of the units at reduced rates to those making no more than 80% of the <u>a</u>rea <u>m</u>edian <u>i</u>ncome - \$70,850 for family of four in Houston. Source: HUD FY 2023 Income Limits Summary

Recently, the HHA has been doing development deals with PFCs at a fast pace, causing concerns on a number of fronts – flooding, traffic, infrastructure, etc., and putting a strain on impacted school districts deprived of commensurate property tax income. *Mayor Turner* has paused all new deals until there is a better understanding of the cost-benefit of the PFC structure. *TX Sen Bettencourt has introduced SB 805* in an attempt to repeal section 303.042(f).

- **B.** Streets: COH has under invested in streets for decades. 11.8 cents of every \$100 in home value was going to street and drainage *debt*. The city no longer goes into debt and is on a pay-as-you-go basis. As debt is paid down, property tax revenue is increasingly available for street and drainage projects, limited by the cap on how much revenue the city can take in. There is also the Rebuild Houston program (*now Build Houston Forward*) that taxes residents based on impervious surfaces which was introduced as a Street/Drainage fee when it was introduced in 2010. Public Works came up with a plan under the mayor's Street Rehabilitation Initiative that provides many of the same benefits as reconstruction, but at a much lower cost. It includes mill and overlay of asphalt roadways and concrete panel replacements.
- *C. Sidewalks:* Alcorn anticipates that a bond initiative to improve city sidewalks makes it to the ballot in a future administration.
- **D.** Trucks Parking in Neighborhoods: has largely been addressed by enforcement (Park Houston) as well as HPD, raising the fine from \$60 to \$150 per incident.
- *E. Noise:* Strengthening of the city's noise ordinance, including permit requirements, and raising the maximum fine from \$1000 to \$2000 has significantly reduced noise complaints.

• Houston Metro (Margaret Dunlap)

Metro is applying for **\$33.8 million** under the US Department of Transportation RAISE discretionary grant program, <u>Rebuilding American Infrastructure with Sustainability & Equity</u>. *If approved, funds will be used on the* **82 Westheimer route** - *Hwy 6 to downtown, directly benefitting SN-17. 82 Westheimer* has the highest ridership in the system and has been identified as a Metro BOOST project, needing significant improvements, such as bus shelters, ADA compliant sidewalks, etc. SN-17 is "boosting" Metro's federal grant application with a letter of support!
